Construction To Begin On New Regional Fire Fighter Training Center

Calumet City will begin construction of a regional fire fighter training facility featuring a state of the art fire simulation rooms, interactive computer generated fire scenario models, traditional continuing education in fire fighting techniques and equipment operation. Calumet City Fire Fighters will be able to learn and improve their knowledge and skills at our facility and we will be able to lease the use of the facility to surrounding communities in Illinois and Indiana.

to know construction materials used, location of hazardous chemicals, methods of identifying people trapped in a burning or exploding structure, and how to protect our safety while getting themselves out alive and intact."

Mayor Michelle Markiewicz Qualkinbush explained that the project was being funded in part by a \$813,465 legal settlement arising from a class action lawsuit opposing the collection of an amusement tax on ticket sales from 1982 through 2000. After 12 years of litigation, the funds were released to Calumet City on the condition that the money be used for a court approved public works project. The additional funds needed to complete the \$1,750,000 project being will obtained through bond proceeds.



"Advancements in equipment and technology for both fighting fires and protecting our Fire Fighters requires additional training and instruction throughout a Fire Fighters career. Most people think they just show up and squirt water on a fire, but it is much more complicated," said Mayor Michelle. "Our Fire Department knows the layout of every large building in town as well as the basic floor plans of every type of residence. They need

Police Officers Undergo Continuous Professional Training



Graduation from the Police Academy is just the start of the continuous education and training our police officers receive in order to provide the maximum protection

possible for our residents. Designed to provide the knowledge needed to deal with almost any public safety emergency that arises, our police officers have undergone training in areas as divergent as blood borne pathogens,

radiation detection, hazardous materials chemical and suicide prevention techniques.

All commanders, officers and civilian employees are kept up to date on our latest technological advancements in



both software and hardware, which include using officer's smartphones to view live video of police response actions transmitted through patrol car mounted cameras.



Officers responding to a scene are able to view what is occurring as it unfolds, allowing them to react faster and better to protect our residents. All police cars are also now outfitted with GPS trackers which allow 911 dispatchers to locate the patrol car closest to an emergency and coordinate the fastest possible response.

The best tool Calumet City has for protecting our safety is the common sense and watchful eye of all of our residents. Monthly crime watch meetings are held throughout the City to alert residents about activity in their neighborhoods and encourage neighbors to look out for their neighbors. To assist our residents in protecting themselves, we continue to refine the use of our Code Red System (Reverse 911), which allows us to immediately convey emergency public safety messages by an automated phone call to your home or cell phone.

New Sewer Water Pump Station To Be Constructed

Whenever it rains so hard and fast that the amount of water flooding into Calumet City's sewer system cannot all be flushed into the Deep Tunnel, the excess water has to be pumped into the Cal Sag from our municipal sewer pumping station. Due to its age and the malfunctioning equipment in the current combined sewer-stormwater pumping station near State Street and Burnham Avenue (built almost 100 years ago), our independent city engineering firm recommended that the facility be replaced before it broke down completely and caused widespread flooding in the northeast section of Calumet City.

In March, the City Council approved a \$5.5 million dollar project to build a new combined sewer-stormwater

pumping station to replace the current facility over the next 18 months. Bids for construction are set to be approved in October 2012, with construction starting in December and ending in the Fall of 2013. The new sewer-stormwater pumping station will include a prefabricated control room with state of the art water flow monitoring systems which will help avoid flooding in side streets or on private property.

The project, to be financed from tax revenue collected on the sewer bills of residents and additional grant money acquired by the city, will also include the demolition and removal of the existing structure and century old fixtures.



Calumet City must keep up with our infrastructure repairs and improvements in order to make traffic flow safely and smoothly through the community. All of the work should be done by the Fall, and in the end it will be worth the inconvenience.

The following projects may have already begun in your neighborhood and will be finished by October as long as the work crews do not run into any complications.

Meet The New Clerk — Nyota Figgs Biography

Nyota Figgs has made improving our community her life's work. Motivated to obtain an education to help her pursue her dreams, Nyota earned a Bachelor's Degree (B.S.) and a Master's Degree (M.S.) from Lewis University in the field of Criminal/Social Justice.

Prepared to work in the community though her charitable work through the Delta Sigma Theta Sorority during her college years, Nyota began her career at Catholic Charities and Family Rescue by helping children and families work their way through difficult circumstance and financial difficulties to get their lives back of track. Nyota has continued to privately help children and families in need through her independently funded Figgs Foundation.

Nyota was recruited to join the Adult Probation
Department of the Circuit Court of Cook County, which
operates under the supervision of the office of the Chief
Judge. Nyota and her colleagues were responsible for
monitoring the actions and behavior of convicted offenders
and help their transition back into society. Nyota worked
with newly released offenders to make sure they were
trying to become productive and law abiding members
of society — working at productive jobs, avoiding
troublesome situations and abstaining from drugs and
alcohol.

Nyota was responsible for determining which offenders were rehabilitated and which offenders were a danger to the community and need to be monitored further or placed in custody.

During her professional career, Nyota continued to expand her education and training by acquiring certifications in training new probation employees, conducting group therapy sessions for offenders and providing individual counseling sessions for clients to improve their lives. Nyota was one of the few nationally certified Cook County

trainers in Protective Service Systems. Nyota also returned to college to acquire a Paralegal Certification from Loyola University of Chicago.

Calumet City residents urged Nyota Figgs to be a candidate for Commissioner of the Calumet Memorial Park District. Nyota was elected with the help of friends and neighbors in April of 2011 and continues to serves as an elected member of the unpaid volunteer Park District board.

Based on her experience and outstanding service as a public sector employee, as a community activist/volunteer, and as an elected official, Mayor Michelle selected Nyota Figgs to fill the vacancy of the Calumet City Clerk in November, 2011.

This information is required by state statute to be filed in the Cook County Clerk's office by the last day of July every year. It should be noted that the budget ordinance that was recently presented by the administration and passed by the City Council reflected expenditures in the Corporate Fund of \$34,558,304. With the estimated revenues in the

Corporate Fund (this is the main operating fund of the City) at \$34,605,949 the projected expenditures result in a net surplus of \$47,645 for the fiscal year.



Looking Out For Your Money

With the deregulation of Commonwealth Edison, the City is now able to buy its electrical power from other suppliers. I saw this as an opportunity to save the taxpayers of Calumet City money and investigated the matter with several energy brokers and cooperative groups.

In May of 2011 the City of Calumet City entered into an agreement with Exelon Energy to provide electrical service for street lighting and power to our water pumping stations. Exelon Energy is one of the largest unregulated suppliers of electricity and natural gas in the nation. With the assistance of NIMEC (Northern Illinois Municipal Electric Cooperative) the City was able to realize a substantial savings in energy purchases.

The City will save 20% on street lighting versus the ComEd rate and 52% savings on electricity to service our water pumping stations.

It is through savings such as this that we are able to keep a handle on our budgetary priorities to serve our citizenry. Look for more information in the near future about the City's efforts to pass these savings along to each and every homeowner in Calumet City through the Municipal Aggregation referendum that will be on the November 2012 general election ballot.

Alderman Magdalena "Leni" Wosczynski and Calumet City Health Commissioner Dr. Juan Tellez hosted a free Health and Wellness Fair for all Calumet City residents and their families on May 12th at the Calumet City Library. Alderman Leni coordinated the participation of 25 not-for-profit health organizations, government agencies and private businesses to inform Calumet City residents on practical strategies for maintaining a healthier lifestyle for their families. Residents were also offered free, on-site medical testing from various area hospitals and medical professionals while enjoying free refreshments provided by Pete's Fresh Market.

Alderman Leni is also wrapping up a series of "Summer Block Meeting" designed to provide her constituents with an outdoor forum to ask questions and talk about issues or problems facing Calumet City and the 2nd Ward. In the months of July and August, Leni held six outdoor meeting on various street corners throughout the ward so that each resident would only have to travel a few blocks to



interact with their alderman, a representative from the Police Department and a representative from the Public Works Department. The meetings were well attended by residents and Leni hopes to repeat the Summer Block series next year in order to bring local government to her constituents on an informal basis.



Alderman Leni also sponsored a "School Supply Give Away" program in which 50 randomly chosen students from the 2nd Ward were given a supplement of school supplies for the upcoming school year. Parents interested in receiving the extra bonus of supplies were asked to apply by sending an email to Alderman Leni's official government email address by August 13th. Alderman Leni randomly chose the lucky recipients and had the supplies delivered to each household prior to the start of the school year.

Enterprise Zones provide incentives to businesses by providing to locate or expand in the form of sales tax exemptions on building materials, equipment and tools, an exemption on the state utility tax, income tax credits, job creation/new employee tax credits and select state income deductions. Local governments can also provide additional incentives in the form of permit and license fee waivers, property tax abatement, sales tax sharing, and business loan assistance.



Earlier this year, the General Assembly voted to extend the life of Enterprise Zones throughout Illinois by 30 years to assist in creating new businesses and jobs. Enterprise Zones were originally authorized in 1982 for thirty years and were set to expire beginning in 2013. The legislation extends their life for another 30 years, including the Enterprise Zone which includes all of Calumet City.

On Saturday, April 21st, Alderman Jones sponsored a "Comcast Cares" day in which local Comcast employees join in with local residents and the Public Works Department employees to clean up and beautify the 3rd Ward.





Residents were also encouraged to help volunteers from the Jones Foundation, Inc. (an Illinois not-for-profit corporation) to prepare care packages to be shipped to U.S. Military personnel stationed in combat zones and for Calumet City college students leaving home for school.



Residents also generously contributed to filling the care packages with the following items: socks, deodorants, crackers, oreo cookies, chocolate chip cookies, canned and dry soup, paper, pens, juice packages, shampoo and body wash. The event was a success in both the improvement of the appearance of the 3rd Ward and the creation of dozens of care packages for the troops and local students.

Alderman Brian Wilson would like to remind all home owners and business owners considering construction and improvement projects to contact the Building Department regarding the need for plan or permits. While minor improvements may not



require the submission of plans or applications, more complex projects involving electricity, plumbing or digging around gas, water and sewer lines need to be approved for safety reasons. The professionals in the Calumet City Building Department will be able to assist property owners in identifying potential hazards in relation to their projects by using utility maps and by referring property owners to J.U.L.I.E. (Joint Utility Locating Information for Excavators) at 1.800.892.0123.

Prior to hiring any contractors to provide property improvements services, home owners and business owners should ask each contractor if they are licensed, bonded and insured for the work they are proposing to do. Most reputable and competent contractors are also able to provide references and addresses for potential customers to review the contractor's prior work product. If any contractor asks to be paid in full prior to the start of work, show them the door. If a home owner or business owner is planning on doing minor repairs or maintenance on their property by themselves or with an employee, please remember to take every precautionary measure and make safety your first priority. Skilled tradesman and handyman services do this for a living, which is how they generally avoid getting hurt.

As Chairman of the Public Works Committee, Alderman Munda's primary concern is to provide oversight of the maintenance of the infrastructure of the city (streets, sidewalks, sewers, water pipes, bridges, etc.) and to make sure the Public Works Department provides the services to city residents need to keep the residences free of rubbish and obstructions. To that end, Roger Munda regularly performs inspection tours of the city, both above ground and below. Without the regular maintenance of our infrastructure, including the immediate repair of potholes and buckles in the streets, our streets would need to be completely resurfaced and replaced beyond our ability to pay through motor fuel tax revenue collections.



Residents concerned about the recent "sinkhole" exposed when a multi-ton fire truck travelled down a residential street need not worry – our streets are safe! Occasionally, a broken water pipe beneath the surface of

the street will wash away all of the supporting gravel and sand beneath the asphalt, creating a void beneath the street. No evidence of a void beneath the street is visible or detectable until a excessive weight vehicle travels over the void, causing a minor hole or a sizable "sinkhole". Although it makes for a good photo and TV news story when these event occur (and they occur all



over the world), it is a rare event. Within a short period of time, the water line was replaced, allowing street repair crews to rebuild the foundation of the street and replace the asphalt.



As part of Alderman Munda's city wide effort to beautify Calumet City, he is providing an incentive for Calumet City home owners to beautify our city and raise property values by sponsoring the BEST HOUSE ON THE BLOCK contest. Planned in conjunction with the Neighborhoods, Inc. not-for-profit organization, contestants are provided free professional advice to complete their home improvements for the lowest cost possible. The first place winner chosen in September will receive \$500 with runners up receiving between \$400 and \$100 each.

Alderman Alderman Nick Manousopolous joined the efforts of the South Suburban Association of Chiefs of Police (SSACOP) to help get illegal firearms off the street to help reduce gun violence in Calumet City and the south suburbs. The Gun Buyback Program was provided \$2,000 by Alderman Nick on June 23rd. In 2011, over 600 guns were taken off the streets of the south suburbs with the help of Alderman Nick.





In addition, Calumet City police will hold a second round of gun buybacks in November, 2012 before the holiday season. The strategy behind the pre-Christmas gun buyback is to provide additional money for the holidays for and family or individual turning in a guns while making the holiday season safer on our streets.



Calumet City has been awarded a \$469,000 grant to assist with the hiring and training of firefighters, including payment the salary and benefits of three new firefighters for the next two years. The SAFER (Staffing for Adequate Fire and Emergency Response) grant is offered through the FEMA (Federal Emergency Management Agency) which is now under the federal department of Homeland Security. The purpose of the grant program is to assist fire departments in increasing the number of frontline firefighters who are trained, certified, and competent to safely respond to emergencies within the local government jurisdictions throughout the United States. The goal is to assist local fire departments with staffing and deployment capabilities so they may respond to emergencies whenever they occur, assuring their communities have adequate protection from fire and firerelated hazards (source: FEMA).

Photograph A photo, clearly identifying program participant, must be placed in the designated spot on the Yellow Dot Medical Card.

This must include: participant's name, emergency contact, personal physician, medical conditions, recent surgeries, allergies and current medications.*

ELECTRIC AGGREGATION

Electric Aggregation = Buying As A Group To Negotiate Lower Prices

The Calumet City Council has approved the placement of a non-binding referendum question on the ballot for the November 6, 2012 general election. Calumet City officials are seeking guidance from Calumet City residents on whether residents would like Calumet City to enter into an agreement which would allow electricity sellers to provide lower electricity rates to individual Calumet City home owners, apartment renters and business owners. The idea is that by purchasing as a group, electricity providers will compete to offer us a lower rate. Other communities who passed this referendum earlier in the year are now able to provide their residents with electricity bills that are 25% lower than their current monthly bills.

In the event the referendum does pass and Calumet City is able to negotiate lower rates for all electricity customers, individual homeowners, renters and business owners will still have the choice of not participating by opting out. Maybe you can find a better deal on your own, and if you can, more (electrical) power to you.

Commonwealth Edison (ComEd) owns and operates the electrical lines that the electricity flows through, and ComEd will still be providing billing, maintenance and repairs for the entire system. However, ComEd's electrical grid and lines runs over public property that belongs to the people of the United States, which is why they must allow individual electricity sellers to offer their product (electricity) through ComEd's lines. As an example of a similar situation, ATT owns the phone lines and phone system, but must allow competing phone service companies like Sprint or Verizon to offer local and long distance calling service over ATT's lines.

More information on the process will be available should the referendum pass, as it has in over 187 Illinois communities to date.
